Helping Minnesota's Department of Correction to launch DOCstat

Project #15 | 2024 to present

- We are supporting Minnesota's Department of Corrections to launch a PerformanceStat initiative focused on the successful implementation of the Minnesota Rehabilitation and Reinvestment Act (MRRRA), a major reform of its criminal justice system.



Supporting Ohio's Bureau of Workers Compensation to launch BWCStat

Project #14 | 2024 to present

- We are helping the Ohio Bureau of Workers Compensation to launch the first ever PerformanceStat initiative focused on this policy area in the U.S. The work kicked off with a strategic planning offsite for senior staff in March 2024.



Helping Ohio's Department of Health to launch HealthStat

Project #13 | 2024 to present

- We are supporting Ohio's Department of Health to develop and launch a PerformanceStat initiative, starting with a focus on two priority topics. HealthStat will be the first PerformanceStat initiative in Ohio government.



Supporting New Mexico's Department of Human Services in launching its Health Care Authority (HCA) Performance Review

Project #12 | 2024 to present

- We are helping New Mexico's human services agency (soon to become the Health Care Authority) to launch a PerformanceStat initiative focused on its priority goals. It will be the first PerformanceStat initiative in New Mexico's executive branch.



Supporting Results for America on Evidence-Based Grantmaking

Project #11 | 2023 to 2024

- Over four convenings, we helped RFA support state education officials to weave evidence into their grant making, as part of RFA's State Education Fellowship program.



Helping Ohio launch a new performance monitoring system

Project #10 | 2023

- We facilitated workshops for state agency staff on the new initiative launched by Ohio's Office of Budget and Management, and provided technical assistance on logic modeling.



Supporting Results for America on evidence-based workforce spending

Project #9 | 2023

- We helped RFA develop an outline and content for a new online resource for state workforce leaders who want to get more ROI from their grantmaking by using evidence and data.



Developing a framework for KidStat in New Mexico

Supporting Tennessee's statewide expansion of program inventories

Project #3 | 2022 to present

- Teaming with EY, this multi-year project is supporting Tennessee's Office of Evidence and Impact (OEI) to expand program inventories to 19 new agencies, helping solidify Tennessee as one of the leading states in the U.S. in terms of evidence-based budgeting.
